



## 2024 *Coraline* in Newly Remastered 3D Ticket Contest

### Official Rules

**ELIGIBILITY AND GUIDELINES:** Contest is open to all currently registered members of Girl Scouts and their parents or caregivers. Employees and board members of Girl Scouts of the USA and affiliated councils and their immediate families are not eligible to participate. The contest is subject to all federal, state, and local laws. Void where prohibited. **NOTE:** *Coraline* in Newly Remastered 3D is rated PG-13.

**HOW TO ENTER:** The contest runs June 25, 2024, through July 19, 2024. To enter, pre-register for the FREE “Exploring Careers in Animation: Behind the Scenes with the Women of *Coraline*” virtual event taking place on July 20, 2024. Registrants will be automatically entered to win. Registrations must be received by 11:59 p.m. on July 19, 2024, to be eligible for the contest. One entry per person. No purchase necessary.

**PRIZE AND SELECTION:** Contest is administered by Girl Scouts of Oregon and Southwest Washington, and prizes are supplied by Fathom Events. Prizes are non-exchangeable and are not redeemable for cash or other prizes. Three winners will be selected to receive a prize pack of four tickets to see *Coraline* in remastered 3D (roughly a \$50 value, value may vary depending on location).
